

TERMS AND CONDITIONS FOR MAR HOTELS' WIFI HOTSPOT

1) INTRODUCTION:

These conditions apply to the internet access service for MAR HOTELS customers (hereinafter the "Service") and constitute a contract between You (hereinafter "You" or "the User") and the entity PALMIRA CORALIAN S.L. (hereinafter "we" or "MAR HOTELS"), with its registered address at Gran Vía Asima, 1 - Polígono Son Castelló - Palma de Mallorca - 07009 - (Illes Balears) - Spain, Tax Identification Number B16637902, registered in the Commercial Register of ILLES BALEARS T 2824, F 197, S 8, H PM 87287, I/A 1 (20.08.19), and in the general register of companies, activities, and tourist establishments of the Balearic Islands and Insular de Mallorca. In addition to our registered address, Users may direct their requests, questions, or complaints to info@marhotels.com.

2) CONDITIONS:

1. The use of the Service is reserved for MAR HOTELS customers over 18 years of age.
2. To register for the Service, the User must request a validation ticket at the reception and connect to the hotel's Wi-Fi to complete the registration form, providing the validation code included in the ticket and a valid email address in which they will receive the activation email. For any issues during the registration process, the User can contact the hotel reception.
3. The email address provided by the User will be used to send commercial communications from Mar Hotels. If the User does not wish to receive this type of communication, they can notify us via email at info@marhotels.com.
4. Registration for the Service can be validly formalized in Spanish and in any other language available in these conditions. In case of discrepancies between translated versions, the Spanish version will prevail.
5. The right to use the Service is non-transferable and is subject to the User's consent to receive Mar Hotels' commercial newsletters. The Service is free of charge for the User.
6. Internet access will be carried out using the User's own electronic devices. The email address provided for registration allows the User to connect a maximum of 5 devices. MAR HOTELS does not provide any technical or technological support to users using the Service.
7. The User assumes exclusive responsibility for actions taken with their identifier through the access, especially with regard to possible criminal or administrative violations. In the event that a breach of these conditions endangers, with or without harm, the MAR HOTELS information system, especially the personal data it contains, the corresponding legal responsibilities will be established.
8. Users agree to use the Service in a lawful manner, in accordance with these conditions, and without causing harm to the rights or interests of MAR HOTELS or third parties. By way of illustration and not limitation, the User agrees to:
 - Not engage in illegal activities or activities contrary to public order or good faith.

- Not attempt to access, modify, manipulate, and, if applicable, use the accounts of other Users.
 - Not use the data published in the Service for sending unsolicited communications (spam).
 - Not disseminate false, misleading, ambiguous, or inaccurate information through the Service that may mislead the recipients of the information, nor any content of a racist, xenophobic, pornographic, terrorism-promoting, or human rights-violating nature or related to minors.
 - Not take actions that violate the intellectual property rights of MAR HOTELS or third parties.
 - Not cause damage to the physical and logical systems of MAR HOTELS, its providers, or third parties.
 - Not introduce or disseminate computer viruses on the network or use any other physical or logical systems that could cause the aforementioned damages.
 - Not delete, alter, bypass, or manipulate any protection device or security system of the Service.
9. The use of the Service and the internet access provided through it is at the User's own risk. Therefore, neither MAR HOTELS nor its administrators, employees, suppliers, or collaborators will be liable for any damages, of any kind, direct or indirect, resulting from such use or access, expressly excluding MAR HOTELS, to the extent permitted by law, from any kind of warranty, whether express or implied. MAR HOTELS does not guarantee the availability, accessibility, reliability, or security of the Service. In particular, MAR HOTELS is not responsible for possible damages caused by interference, interruptions, computer viruses, disconnections; delays or blockages in the use of the Service; or any other alteration that may occur in the User's Software or Hardware. It also does not guarantee the absence of viruses, malware, Trojans, or other elements that may cause alterations to the computer system, documents, or files of the User, excluding any liability for damages of any kind caused to the User for this reason. Similarly, MAR HOTELS will not be liable for damages caused by other users or third parties through illegitimate intrusions beyond its control.

MAR HOTELS reserves the right to suspend or cancel access to the Service at any time, especially, but not limited to, those users who violate these conditions; in the event of unforeseen technical or security problems; or in compliance with a police, judicial, or administrative requirement and/or order. Such cancellation or suspension will be at the exclusive discretion of MAR HOTELS and will not result in any form of compensation.

The intellectual property rights over the elements and contents of the Service, such as the domain name of the portal that provides access to it, its source code, design and navigation structure, and elements contained therein (including but not limited to images, sound, audio, video, software, or texts; trademarks or logos, color combinations, structure and design, etc.), are owned by MAR HOTELS, who has exclusive rights to exploit them in any form, especially the rights of reproduction, distribution, public communication, and transformation, as provided by current Intellectual Property Law. 12. If a clause of these conditions is declared null, it will only affect that provision or the part that has been declared null, with the conditions remaining in force in all other respects, and the affected provision will be considered void.
13. Access to the Service and its use necessarily imply the express acceptance of each and every one of these conditions by you.

Without prejudice to the rights granted to consumers by Royal Decree-Law 1/2007 of November 16, the use of the Service will be governed by Spanish law, excluding its conflict of laws rules, and any dispute that may arise from it will be submitted to the jurisdiction and competence of the Courts and Tribunals of Palma de Mallorca, with users expressly waiving their own jurisdiction if they have any.
